Now that we are “out of the dirt” and closer to project completion, we have an opportunity to expand the project’s scope of work and add important features that will make a huge impact to our membership, our club, and our community. With additional funding, the Club could launch the expansion from a position of strength with several “future” projects completed before opening.

### WE CAN DO MORE WITH YOUR HELP

Sample project elements we would like to address between now and opening include:

Sealing and lining the entire parking lot (not just the new spaces)

Re-carpeting existing Harbor Club veranda (currently torn and worn, especially where the old and new verandas will meet)

Purchase member grill veranda and patio furniture (vs reusing existing patio furniture until it can be purchased at a later time)

Add vinyl wallpaper to event center ballroom, lobby, and restrooms to make it competitive with similar venues (vs paint)

Purchase upgraded Chiavari chairs for event center ballroom (versus renting for each event until they can be purchased at a later time).
